In response to the Project Investment Justification (PIJ) for the “**Emergency Notification Reverse 9-1-1**” project, the Arizona Department of Administration (ADOA) Strategic Enterprise Technology (ASET) office has reviewed your proposal to implement a statewide Emergency Notification Reverse 9-1-1 system. This tool is a mass communication tool designed to rapidly and efficiently disseminate critical information to a targeted audience during emergencies.

The PIJ implies funding is available from the Base Budget, Federal, Other Non-Appropriated in the amount of \$4,966,500.00 for the total estimated five-year life cycle cost for the project, which is shown below.
