In response to the Project Investment Justification (PIJ) for the "Analytics & Survey Solution" project, the Arizona Department of Administration (ADOA) Strategic Enterprise Technology (ASET) office has reviewed your proposal to develop surveys to collect, manage, analyze, and visualize data that will be generated during the Student Nurse Clinical Rotation and Licensed or Certified Nurse Training Pilot Program (1803 Grant).

The PIJ implies funding is available from the Federal in the amount of \$1,724,817.00 for the total estimated five-year life cycle cost for the project, which is shown below.
