# Director Rodgers,

In response to the Project Investment Justification (PIJ) for the "DTS Zero Trust Access Model" project, the Arizona Department of Administration (ADOA) Strategic Enterprise Technology (ASET) office has reviewed your proposal to implement a zero trust model to increase security and decrease resolution times for supporting remote workers through application performance monitoring.

The PIJ implies funding is available from the Base Budget, Other Appropriated, Federal, and Other Non-Appropriated in the amount of \$3,162,956.87 for the total estimated five-year life cycle cost for the project, which is shown below:
