In response to the Project Investment Justification (PIJ) for the "**HEAplus REACH SR1045\_1046**" project, the Arizona Department of Administration (ADOA) Strategic Enterprise Technology (ASET) office has reviewed your proposal to develop an ALTCS public user portal to register initial applications and develop additional improvements to HEAplus will add mobile responsive solutions for public users using a desktop, tablet, or mobile device.

The PIJ implies funding is available from the Base Budget, Federal in the amount of \$4,816,000.00 for the total estimated five-year life cycle cost for the project, which is shown below.
